

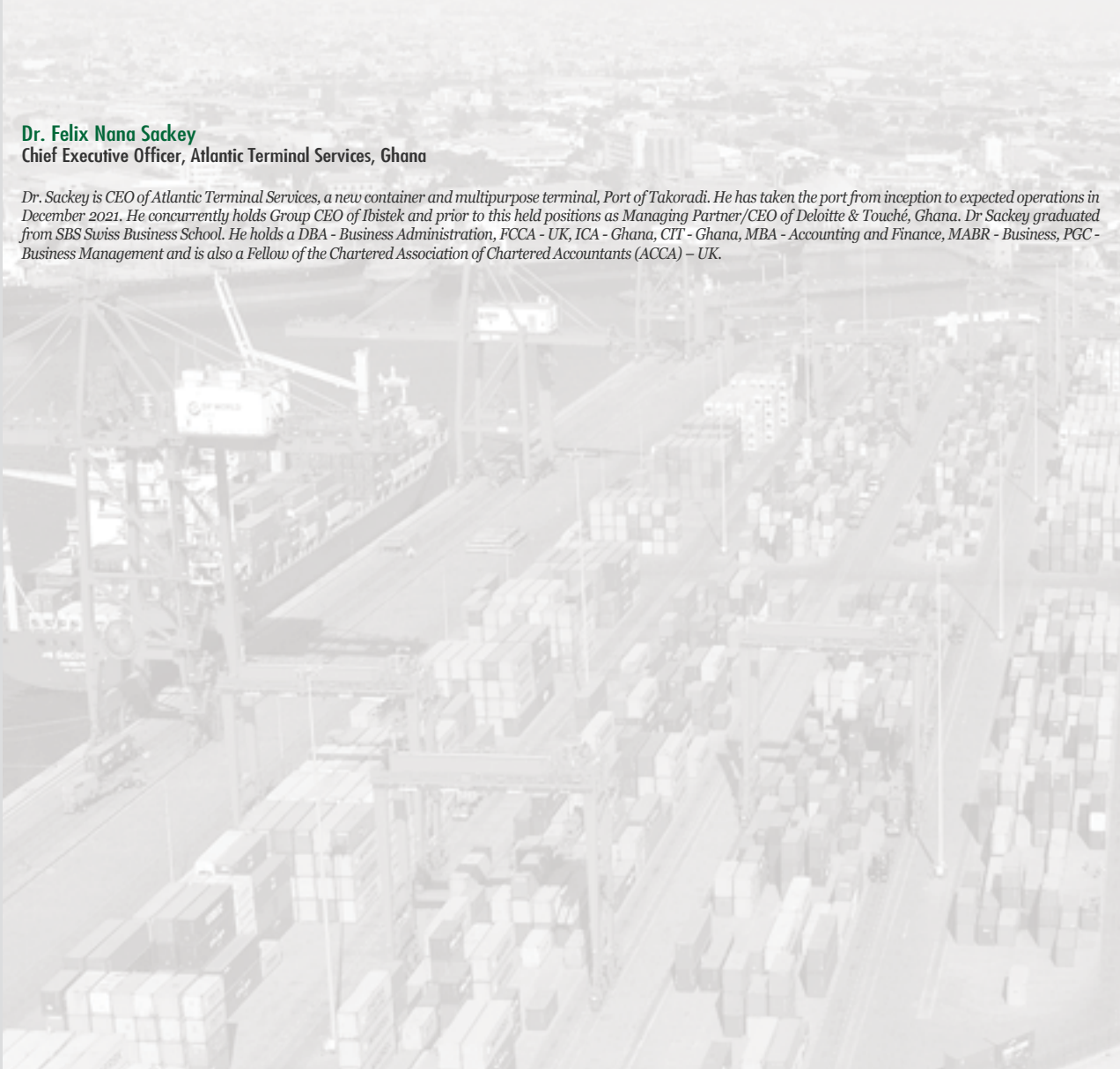
Joris Thys

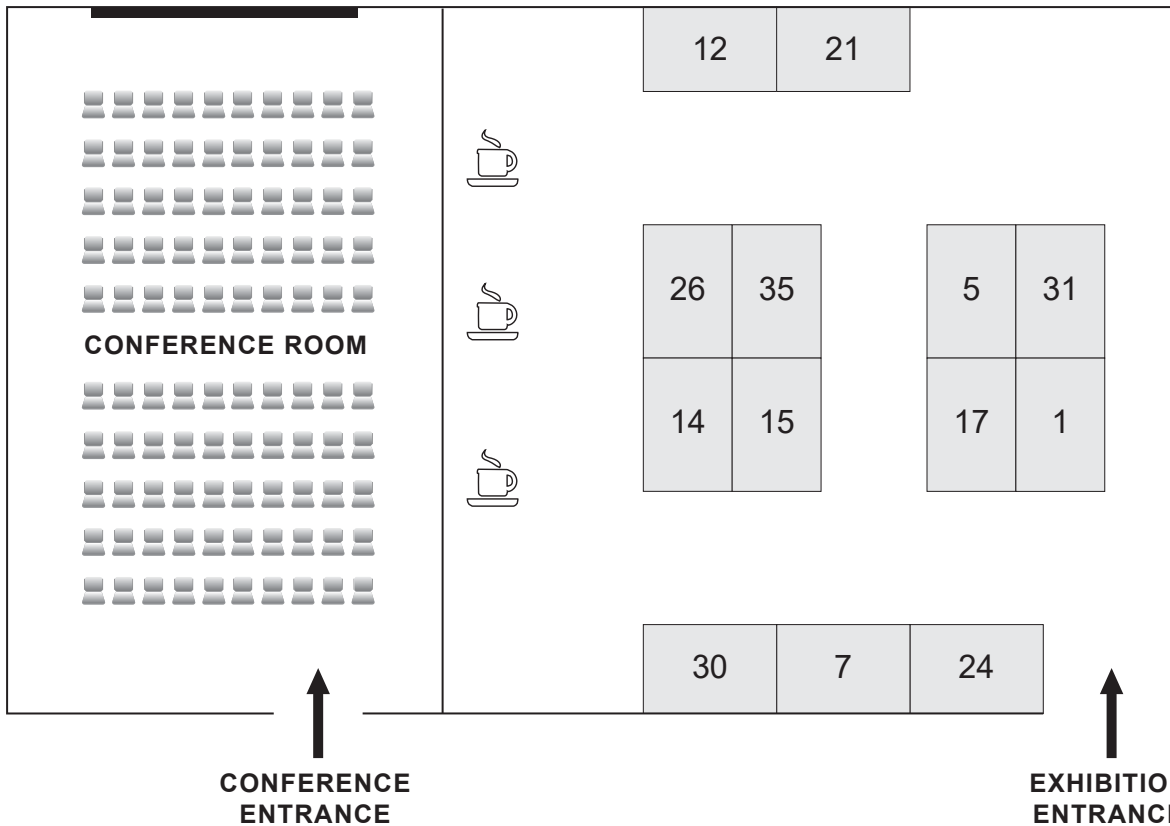
