






State Ports vs Major Ports - Models

TAMP

- While the tariffs for the Major Ports are regulated by the Tariff Authority for Major Ports (TAMP), the Non-Major Ports under the States are free to set their tariffs based on the competition. This has put the Major Ports in a disadvantageous position in offering competitive tariffs as compared to Non- Major Ports. The existing method of fixing tariffs by TAMP is contrary to international best practice and leads to various anomalies. This has also led to tariff differentiation between berths at the same port. The port tariffs needs to be deregulated in the commodities where sufficient competition is available.
