

Handling Hazardous Materials

Pesticides, Water Treatment Chemicals, Detergents and others, especially hazardous ones, require specialized handling, transportation, and storage. Example: Flammable, corrosive, or toxic materials need special containers and precautionary measures.






Regulatory Compliance

- **Documentation**: Complex documentation for hazardous chemicals is required to ensure proper handling, classification, and customs clearance.
- Example: Special permits for import of pesticides, seeds etc
- Customs and Tariff Challenges: Exporting chemicals across borders faces delays due to varying regulations, customs procedures, and tariffs

- Global and Local Regulations: Different countries have different rules for chemical transportation and handling.
 - Example: The REACH regulation in the EU-Specific label size with specific details
 - Example: Special labels for pesticides as per DDC Act





Temperature Sensitivity and Storage

- Perishable Chemicals: Some chemicals, especially pesticides, enzymes and seeds among few others, require temperaturecontrolled transportation and storage to avoid degradation.
- **Cold Chain Logistics**: Maintaining the integrity of temperature-sensitive products is an ongoing challenge, requiring refrigerated containers and controlled environments.

Exemple : Sodium Hypochlorite Solution(Javel at 12%), Peroxides







Supply Chain Disruptions

- Force Majeure: Weather events, natural disasters, and geopolitical issues can severely disrupt the logistics of chemicals.
- Example: major delays on orders from Israel due to conflicts in the region





Key Challenges in Logistics at Blychem Ltd Environmental Concerns

- Sustainability Pressures: There is growing pressure to reduce the carbon footprint of logistics operations in the chemical industry.
- Eco-Friendly Packaging: Finding sustainable packaging solutions that do not compromise safety or quality of chemicals.
- Waste Management: The disposal and recycling of chemicals and packaging materials is another critical challenge for the logistics sector in the chemical industry.







Cost Management

 High Transportation Costs: Due to the need for specialized equipment and handling, transportation costs in the chemical industry are higher than in many other sectors.





Cost Management

- Inventory Management: Maintaining an optimal balance between supply and demand is difficult. We are compelled to import products as per supplier's exigencies for minimum order level which for our market is excessive and tend to lead to high storage costs.
- Fluctuating Fuel Prices: The rising costs of fuel significantly affect logistics costs, particularly in road and air transportation





Labor and Skilled Workforce

- Lack of Skilled Labor: The chemical logistics sector often faces a shortage of skilled labor trained in handling hazardous materials.
- Labor Costs: Increasing labor costs can drive up overall logistics costs.


