

THE "TYPICAL" PROJECTS STRUCTURE




CONTRAST BETWEEN 2 TYPICAL PORT DEVELOPMENT SCHEMES: INTERFACE RISKS






1. The biggest port north of Iran


CROSSING TO NORTH- SOUTH INTERNATIONAL CORRIDORS















ASPECTS OF THE MAKRAN MOTHER PORT:



- An advantage of an industrial park established within the proposed free trade zone is its proximity to available energy resources as well as being located on the famous silk route allowing easy access to central Asian states
- Investment possibilities independently or in partnership with Iranian entities with no limit on investment and shareholding
- Foreign investments up to any ratio (of capital investment)
- Proposed 20 years of all tax exemption
- Governmental investment guarantees
- Offshore banking and non-banking crate practices.
- Proposed 100% free repatriation of capital and profit at any time.
- Vast pool of manpower at all levels of skill and business-friendly trade and employment regulations
- Proposed relaxation of visa requirements for foreign nationals
- Tax exemption for export of manufactured commodities into the mainland
- Access to deep waters & being located very close to international shipping routes
- Existence of gas pipelines
- Existence of storage facilities and oil jetty (crude & oil products)
- Strategic location (by the export corridor of a large percentage of global fossil fuels)
